REVERSE TRANSFER AGREEMENT between

Washtenaw Community College

Eastern Michigan University

Eastern Michigan University (EMU) and Washtenaw Community College (WCC) share a long history of working together to improve programs and services to students who transfer between the two institutions. Building on this successful relationship and the many agreements already in place between the two colleges, EMU and WCC agree to collaborate to assist students who have earned credits at WCC, but enrolled at EMU before completing their associate's degree, to transfer credits earned at EMU back to WCC for the purpose of completing an associate degree.

Both institutions agree that students who begin their studies at WCC and then transfer to EMU should be able to transfer at a time that is most appropriate for their individual circumstances and also be able to earn both an associate's and a bachelor's degree.

To fulfill this agreement, EMU and WCC agree to:

- appoint contact persons to act as liaisons for the initiative,
- develop a process to identify students who have transferred to EMU without completing an associate degree and meet specified criteria,
- share student information as needed in a manner that complies with state and federal regulations,
- collaborate to inform students of this opportunity and to provide advising and support to students who want to participate
- develop a process and timeline for implementing the initiative,
- meet regularly to provide feedback on the progress and success of the initiative,
- and explore opportunities to improve and expand the program through new technology and innovative methods and activities.

The following attachments provide additional detail for implementation of the agreement:

Attachment 1: A sample notification message to inform students of their ability to complete an associate degree using the reverse transfer process; and

Attachment 2: A set of criteria and process for selecting students who might benefit from the agreement.

The agreement will remain in effect unless terminated by one of the parties by giving ninety days written notice to the other party. Attachment 2

Reverse Transfer Agreement Process

Eastern Michigan University and Washtenaw Community College agree to the following process for identifying and informing students of the opportunity to earn an associate degree through reverse transfer:

- WCC will create a list of former students who have transferred to EMU without obtaining an associate degree.
 - A list of WCC students enrolled at EMU will be obtained from the National Student Clearinghouse
 - The list will be analyzed by graduation auditing software and narrowed to former students who have not earned a degree at WCC but are within 15 credits of degree completion, and are in good standing.
 - To allow for matching with records at EMU, each record will include name, date of birth, and high school attended.
- The list will be delivered to EMU's Office of the Provost as a spreadsheet or text file.
- Identified students will be sent an email notification of the opportunity and simplified procedure for applying for a degree in.
- EMU will waive the transcript fee for students using this process.
- WCC will provide annual feedback to EMU on students who obtain a degree through this
 agreement.

Timeline

September 20 – WCC to obtain student names from the National Student Clearinghouse

January 8 – records sent to EMU

January 15 – email notifications sent to students

June - Follow up meeting to examine results and make changes to process
